ठाणे, दि. २७ (वार्ताहर) : कोरोनाच्या संसर्गाचा धोका पुन्हा एकदा वाढताना दिसत असून ठाणे आणि कल्याण महापालिका क्षेत्रात दोन रुग्णांचा मृत्यू झाल्याची माहिती समोर आली आहे. या पाश्र्वभूमीवर ठाणे जिल्हा परिषदेच्या आरोग्य विभागाने खबरदारीचा उपाय म्हणून ग्रामीण भागात सर्वेक्षण मोहीम सुरू केली आहे. या मोहिमेअंत आरोग्य कर्मचारी घोघरी जाऊन नागरिकांमध्ये सदी, खोकला, ताप अशी लक्षणे आहेत का, याची तपासणी करत आहेत.
